2018 Georgia O’Keeffe: Visions of Hawaii Sweepstakes | July-August 2018 Maui Vacation for Two at the Hyatt Regency and Andaz Maui

Introduction: The New York Botanical Garden (“NYBG” or “Sponsor”) is hosting an Enter to Win sweepstakes for one Hawaiian vacation package to Maui. This package includes air travel for two provided by Hawaiian Airlines, Inc. (“Hawaiian Airlines”) (\$5,328 value), plus a four-night stay including room, tax, resort fee and daily breakfast for two at the Hyatt Regency Maui Beach Resort & Spa (\$2,400) and a three-night stay including room, tax, resort fee and daily breakfast for two at the Andaz Maui at Wailea (\$2,700). Total retail value is \$10,428. There will be one drawing the week of September 10, 2018. **NO PURCHASE IS NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

2. Eligibility: Each entrant must be a legal a resident of the fifty (50) United States or the District of Columbia, and must be 18 or older as of July 1, 2018.
